# LL.M. in European Business Law

## Programme overview

The oldest programme covering European economic law in Scandinavia provides in-depth understanding both of practical and theoretical aspects of European economic law, and the operation of the rules of the European market in a global context. The programme provides a solid foundation in the EU constitutional framework, which underpins the regulation of the European market. Students are able to tailor the programme to suit their interests and future career through specialisation, in particular during the second year of the programme.

## Programme modules/courses

**COURSES IN THE 2 YEAR PROGRAMME (WITH NUMBER OF CREDITS):** Compulsory courses (in total 75 credits): EU Constitutional Law (12), Business Negotiations (3), Internal Market Law (12), Argumentation and Methodology (3), EU Competition Law (15), Master's thesis (30). **Elective courses (in total 45 credits)** in areas such as: competition law, IP law, tax law, law in the digital age and the European Law Moot Court Competition, etc.

**COURSES IN THE 1 YEAR PROGRAMME (WITH NUMBER OF CREDITS):** EU Constitutional Law (12), Business Negotiations (3), Internal Market Law (12), Argumentation and Methodology (3), EU Competition Law (15), Master's thesis (15).

## Career prospects

With a unique combination of traditional legal studies in EU business law (i.e. the law of the internal market, tax law and competition law) and economic- and trade-related issues, this programme is an ideal preparation for a career within private practice, national/EU institutions, or legal research. It also provides an excellent basis for students interested in pursuing an academic career.

## Entry requirements and how to apply

### ENTRY REQUIREMENTS

At least a three-year Bachelor's degree in law (LL.B or equivalent). English Level 6 (equivalent to IELTS 6.5, TOEFL 90). See [www.lunduniversity.lu.se](http://www.lunduniversity.lu.se) for details on English proficiency levels.

### HOW TO APPLY

**1. Apply online:** Go to [www.lunduniversity.lu.se/european-business-law](http://www.lunduniversity.lu.se/european-business-law). Click on "Apply" and follow the instructions for the online application at [www.universityadmissions.se](http://www.universityadmissions.se), the Swedish national application website. Rank the chosen programmes in order of preference.

**2. Submit your supporting documents:**

- **General supporting documents:** Check what documents you need to submit (i.e. official transcripts, degree diploma/proof of expected graduation, translations, proof of English, passport) and *how* you need to submit them at [www.universityadmissions.se](http://www.universityadmissions.se).
- **Programme-specific supporting documents:** When applying for the Master's in European Business Law, you must also submit a statement of purpose and two letters of recommendation with you application.

**3. Pay the application fee** (when applicable).
